 Our mission is to renew neighborhoods impacted by poverty and restore homeowner pride. We do this by providing exterior home improvements such as painting, landscaping and basic structural or cosmetic repairs. Qualified homeowners to receive Hearts & Hammers support are elderly, disabled or both. Income must fall below 250% of the Federal Poverty Guidelines and homeowners must commit to remaining in their home for a minimum of two years after work is completed. The impact of our accomplishments is hard to monetize. The homeowners we help express joy and gratitude for helping them repair things like front steps, wheelchair ramps and rotting window sills. They have often exhausted every other angle to help complete minor exterior repairs such as these. For the companies and organizations that sponsor a home, the experience is unforgettable. The accomplishment of completely transforming the exterior of a home in one day is a true testament of teamwork. Often, our homeowners meet and perso
