Twin Cities Homeowners Application

ELIGIBILITY REQUIREMENTS:

- You own and live in a single-family home located in the Twin Cities Metro Area (Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, or Washington counties).
- You have lived in the home for at least two 2 years and intend to remain in the home for at least the next two years.
- Your name appears on the property deed or you have a documented legal ownership interest.
- **Not eligible:** townhomes, duplexes, side-by-sides, condos, and mobile homes.

2. Personal Eligibility + Income Requirement: Your household must meet both of the following (A. Personal Criteria + B. Income Criteria):

A. Personal Criteria (at least one must apply)

- Age 60 or older, OR
- Under 60 with disabilities (this may include the homeowner's child who lives in the home and who has disabilities) OR
- A U.S. military veteran or the surviving spouse of a veteran

B. Income Criteria (must meet): Your total household income for the previous calendar year must not exceed:

NOTE: Homes will be considered based on the availability of volunteers, materials, and scope of work.

What We Do:

Hearts & Hammers provides exterior home improvements completed by volunteer teams. Work may include:

- Exterior Painting
- Caulking/Weather-stripping
- Repair or Partial Replacement of Damaged Siding, Fascia, or Trim
- Accessibility Ramp
- Railings Repair
- Stair/Walkway Repair
- Windows/Doors Repair
- Gutter Repair
- Deck/Porch Repair
- Landscaping Renewal

The purpose of this work is to restore the character of the home and the surrounding neighborhood and to improve the home's safety and security.

What We Do NOT Do:

- interior refurbishment
- major electrical work
- plumbing services
- roofing
- putting up a new fence
- major construction projects

I also grant Hearts & Hammers unrestricted permission to use, copy, reproduce, alter, display, distribute, publish, and/or exhibit any pictures, video, or narrative in which I may be included through any means of communication whatsoever for any lawful purpose. I further release and discharge Hearts & Hammers from any and all claims arising out of such use or activity. In no event will Hearts & Hammers be liable for any incidental or consequential damages.
